

**ARTICULATION AGREEMENT**  
**BETWEEN**  
Oakland City University  
**and**  
**BIR TRAINING CENTER**

This Articulation Agreement ("Agreement") is entered into between Oakland City University (OCU) and **BIR Training Center** ("BIR") in order to allow the credits from specific courses listed on the attached Course Sheet and completed at BIR Training Center to transfer to OCU. This Agreement will allow students who attended BIR to continue their education at OCU without the loss of these specific credits earned by the student at BIR. The attached Course Sheet lists side by side which OCU and which BIR courses in which programs are deemed by the parties to be equivalent courses, and thus accepted for transfer credit.

Students who complete any of the BIR courses listed on the Course Sheet with a grade of "C" or better may apply to OCU to transfer credits from those BIR courses to OCU, and OCU will unconditionally accept for transfer credit the credits earned in those courses in fulfillment of the equivalent OCU course and apply those credits towards the Business Administration bachelor degree program at OCU. Since the effective date of this agreement, the courses and credits listed on the Course Sheet have been and continue to be unconditionally accepted by OCU.

Students who would like to transfer BIR credits to OCU must submit to OCU an official copy of their BIR transcript as well a completed OCU credit transfer application, and must pay any transfer credit fee required by OCU.

Transfer credits are not included in the GPA of the OCU student. Students may transfer to OCU a maximum of 30% of the total scheduled credits for their program.

This Agreement will be in effect for five years from the date of execution, unless terminated earlier. This Agreement may be terminated by either party with thirty (30) days advance written notification to the other party.
